the biennial international conference on case based reasoning iccbr ries which began in sesimbra portugal in 1995 was intended to provide an international forum for the best fundamental and applied research in case based reasoning cbr it was hoped that such a forum would encourage the growth and rigor of the field and overcome the previous tendency toward isolated national cbr communities the foresight of the original iccbr organizers has been rewarded by the growth of a
